### General Manager's Report –

- ATCCA has received some funding to assist customers who are unable to pay their water bills, the District has submitted the application and Lori will reach out to affected customers.

### *Water Committee - Vice President Schultz ~*

- **Continuing discussion regarding the water tank project** – The Contractors are painting the exterior of the new tank and all inground work is complete. The remainder of the metal was brushed instead of sand blasted to mitigate concerns from the neighbors.  
**Infrastructure Needs** – RCAC TA request is pending State approval.
- **Water line extension** – Vice President Schultz will contact Supervisor Axe to see if he can assist in finding funding for the hydrants on Lupe.

### 6) **Personnel & Safety Committee** – Director McDonough and President McCann

New Board member will begin in July

### 7) *Pine Grove Community Service District Park President McCann and Director McDonough* –

The deed restriction has been filed with the County and the funding acknowledgment sign is on order. The Concrete Contractor can't meet the State requirements so a new contractor will need to be found. Kevin provided a contact for Lori to talk to.

### 9) *Grants & Finance Committee – Director Schlaman* –

- A meeting was held with the Accountant and some items will be moved in the financial statements to appropriate categories in the April and May finances.

MOTION was called for by Bd. President McCann Director Schlaman moved, Director Schultz seconded and with Aye votes by Directors Schultz, , McCann, McDonough and Schlaman, the Board offered approval for the budgets with the knowledge that final revenue numbers will be solidified when the new rate study is complete.

- Five year Water budget and one year park budgets were reviewed. Revenues have been assumed to balance the annual expenses pending the new rate study.
